Coronavirus: South Africa at Level 4 - Goscelin Gordon MICS

South Africa continues to grapple with the Coronavirus (Covid-19) pandemic. After being under a Level 5 "hard" lockdown throughout April, Level 4 was entered on 1 May. Level 4 allows for more economic activity to be conducted than under Level 5, although many restrictions remain.

On 29 April, a set of new Regulations to the Disaster Management Act were gazetted, although the Amended Regulations to the same Act issued in March continue to apply unless specifically amended or withdrawn by the new Regulations.

In respect of transport, salient points of the Regulations include that borders remain closed except for the transportation of goods, cargo, and fuel as well as designated Ports of entry. Cargo is permitted to be moved by air, rail and sea subject to several restrictions. These restrictions include the import of defined essential goods; including but not limited to food, disinfectants and sanitizers, personal toiletries, medical and hospital supplies, and fuel- including coal and gas. Certain imports for the manufacturing sector are also permitted, as well as transport for cargo at ports of entry, cleared goods destined for neighbouring Countries, transport of goods within South Africa and as further determined by the relevant Minister from time to time. Certain exports are also allowed, including agricultural, forestry and fishing products as well as certain manufacturing and mining products- although these are subject to Directions issued by the relevant Minister.

On 4 May new Directions, repealing previously issued Directions, were issued by the Minister of Transport, which are 'Measures to Address, Prevent and Combat the Spread of Covid-19 in Sea Ports.' These Directions are applicable to South Africa's commercial ports. These directions include provisions relating to improved hygiene and sanitation measures at entrances and exits at Ports and Screening of Port users for Covid-19, as well as stating that physical distancing measures must be taken in Ports. Additionally, Cruise ships are prohibited from calling, with the exception of disembarkation of returning South African crews/ permanent residents. The Directions also provide that South Africans are advised not to use this form of travel until further notice. All passenger vessels may only call in a South African Port to disembark South African crew, returning citizens or permanent residents, or to replenish fuel and obtain provisions. Research and marine tugs are allowed but are subject to any mandatory quarantine laws. All other cargo vessels may dock for purposes of cargo work, repairs, or to take on fuel or provisions. South African crew who disembark in South Africa are subject to a mandatory quarantine period of up to 21 days. Medical Evacuations off the coastline are permitted subject to mandatory quarantine of 21 days. The Directions further allow for transport of cargo from Port to their "final destination," transport of goods to Port for export and loading and offloading of cargo in commercial Ports.

On 13 May President Ramaphosa announced that it is anticipated that most of South Africa will move to a Level 3 lockdown by end of May- barring harder hit areas which may remain under Level 4 restrictions, and further that the Level 4 Regulations will be updated in the coming days. While at this stage it is not entirely clear what the Level 3 Lockdown will look like, it is definite that these are difficult and uncertain times worldwide, and it is likely that the movement of goods and people going forward will continue to be impacted by measures to avoid transmissions of Covid-19 for the foreseeable future.


